There are four main ways that you can make your donation:

The donation form is required to ensure that your donation is properly allocated to the fund and we can then send a 'thank you' note for all donations over £500.

Please note that it may take up to 2 weeks for your cheque to be presented because Sheffield Park Station is closed with only limited access to collect correspondence.
